#### Lesson topic

This course is designed to provide those who intend to use international arbitration in the near future with sufficient background, basic theory, and practical structure of international arbitration. The lectures will include presentations on the latest developments in international arbitration by invited guests, such as researchers, practicing lawyers, and persons in charge at arbitration offices, to give the lectures a three-dimensional feel. In addition, time will be set aside for discussion with the guests so that students can actively participate in the class.

#### Lesson target

The goal of the course is to provide students with a correct understanding of the current theory and reality of international arbitration, and to give them sufficient knowledge to become future users of international arbitration.
