II. Details and impressions / 詳細と感想

In the end of 2021, I had an unforgettable internship in JLPW law firm. When I first heard that I was able to intern at JLPW, I was extremely looking forward to the internship, I was excited but also very nervous. I was excited because Malaysian law is a new challenge for me, Malaysian law include the common law system as well as Sharia law, its characteristics of multicultural and different religion are the things that I had never been exposed to. I was also very nervous because, due to the COVID-19 pandemic, I could not come to Malaysia, I was only able to participate in an online internship. I'm not very clear about whether I can communicate effectively with lawyers online, and whether I can learn a lot of useful knowledge and experience like an offline internship. Besides, I know JLPW is one of the top law firms in Malaysia and I don't know if I am capable of completing my internship.

Before internship, I also thought about the purpose of my internship. One of the purposes was to gain an understanding of the legal environment in other jurisdictions abroad. In addition, I would like to have a deeper understanding of the profession of lawyer to determine whether I am suitable to become a lawyer after graduation. During my internship, on the first day Gloria introduced her team to me. And then give me a task to draft privacy policy for their client. Their client provided medical tourism services for visitors. She also gave me a lot of other documents as references, including the personal data protection act, the

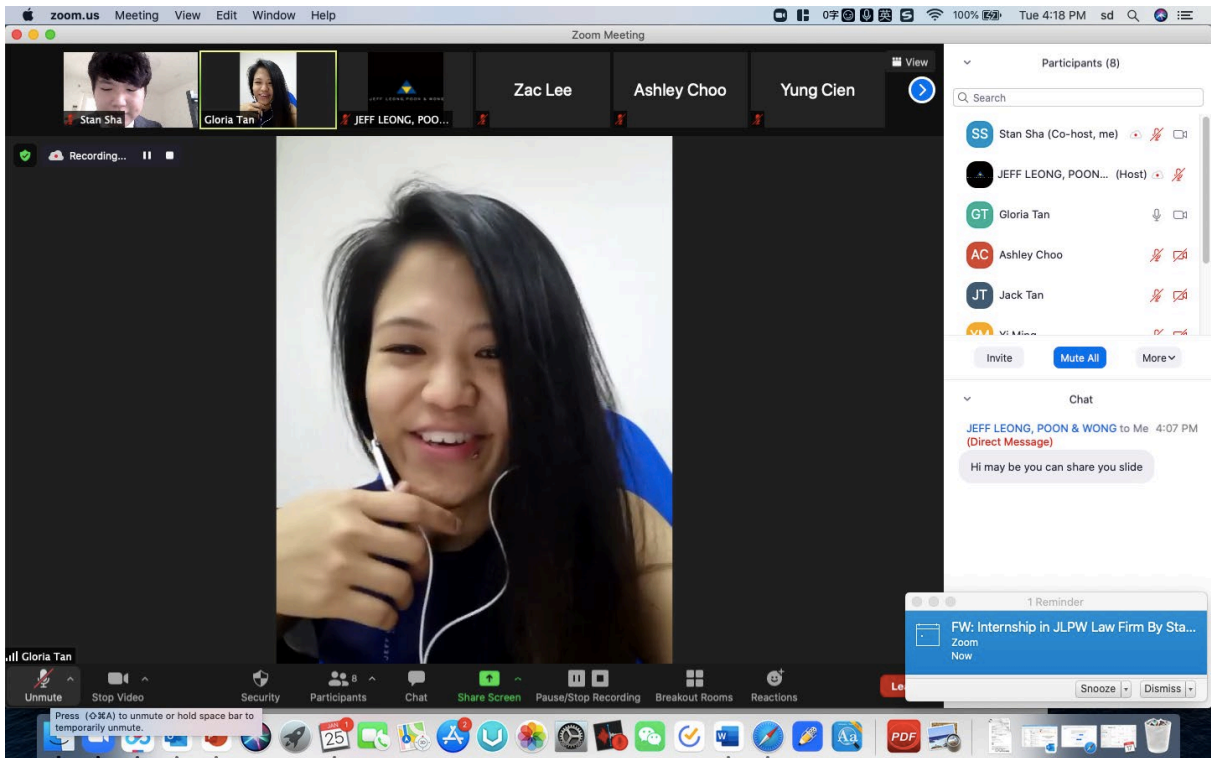
personal data protection regulation, and 2 privacy policy samples which is also relevant to medical and tourism. Gloria gave a very detailed explanation of my task and also ask me to pay attention to the provisions of sensitive personal data.

After I received the task, I first study on the laws and regulations for personal data protection in Malaysia. Although the law is very long and complex, I pay most of my attention on the parts related to drafting privacy policy, and if I encounter difficulties in understanding them, I will first search relevant information on the Internet with the Chinese personal information protection law that I am familiar with to understand it. Besides, I will analyze the scope of the business of the company covered by the 2 privacy policy samples which Gloria gave me and analyze whether there is a difference between them and our client. Finally, I drafted the new policy mainly according to the sample policy, which focused on the sensitive personal information section.

Looking back on my internship at JLPW now, I have gained a lot of experience and knowledge. First of all, I have made new friends in Malaysia, everyone is very kind and they are willing to help me and answer my question. Besides, this internship allowed me to apply what I had learned in my books to practice. I start to have a general understanding of the Malaysian legal system, and learned how to quickly find the laws of different countries. I will also compare and think about the differences between different legal systems. Finally, I have a better understanding of how lawyers work in Malaysia, what kind of work lawyers will do. I aimed to become a professional and international lawyer in the future and this experience strengthened my determination to become a lawyer after graduation. At the same time, I also realized that there is a gap between reality and ideals, and the complex tasks and excellent lawyers I met in this internship have made me aware that my current experience and ability cannot support me to become a good lawyer. I have to study harder and gain more experience to achieve my dreams.
