## II. Details and impressions / 詳細と感想

### 1. Working Experience at JLPW

Since one of my purposes for this internship was to understand the situation of dispute resolution in Malaysia, I was assigned to the dispute resolution department. Three lawyers and one paralegal were assigned to supervise me, but the whole dispute resolution team helped my internship. They all kindly took care of me and arranged observation of court hearings and client meetings. I was given some tasks depending on the court cases they had, while other interns in the corporate team were given tasks to work on throughout the internship. Thus, although I had to find my jobs myself from time to time, I could work on cases that were actually happening at that time and get involved in a wide range of jobs, such as drafting legal documents, legal research, and observing hearings and client meetings.

Drafting a letter of demand was practical, but I could get some points that will be useful for my future legal career. First, I read a case file and checked all emails, letters, and bills. Then, I made a chronology of the case to sort out. After that, I wrote a letter of demand and discussed how to improve it with my supervisors. Thanks to this task, I could learn practical legal English and how to write easily understandable legal documents using abbreviations.

I was asked to research some legal proceedings and precedents. It was the most difficult task for me, but I could ask questions anytime and see real documents to deepen my understanding. For example, after



I researched the gamishee proceedings by reading the rules of court and some articles, I explained it to my supervisors, and they checked my understanding and added some explanations. Then, after I researched it again, I asked a lawyer to show me documents of the gamishee proceedings filed and served in a real case. Thanks to these documents, I could see firsthand how the procedures I researched were actually carried out, what kind of paperwork was involved, what kind of timeline was involved, and what roles the court and representatives would play in the process. More fortunately, I could observe an examination of a judgment debtor in the court, which is one of the steps related to the gamishee proceedings. One of the biggest advantages of the internship is that we can learn how a case proceeded through reading real documents and attending hearings.

In addition, I had an opportunity to observe an online hearing. Due to the pandemic of COVID-19, online hearing is often used in Malaysia, contributing a lot to time and cost savings. I could learn how online hearings proceed and how they affect lawyers working styles compared to physical hearings. In addition to online hearings, I learned about digitalization's development in Malaysia's litigation. For example, they have an e-Filing system, and parties can file and download all documents from that system. More surprisingly, in minor cases, the representatives can chat with judges online to reduce the effort of going all the way to court for a short hearing. I was very interested in this e-Filing system, and my supervisors kindly taught me how to use it and to chat with judges.

I was quite lucky because I could learn how a case proceeded by attending client meetings and court hearings. Moreover, I accompanied lawyers to three court hearings and could feel the adversarial court proceedings. Thanks to my supervisors, I could also observe criminal, intellectual property, construction, and federal court hearings.

#### 2. Interaction with Locals

During the internship, I had many opportunities to interact with the locals and deepen my understanding of Malaysian culture. For example, I participated in sports events weekly, in which we played badminton, bowling, and tennis with JLPW lawyers. In this event, I could communicate with lawyers in other departments where I did not have enough opportunity to know each other in daily work, so it was important for me to broaden my network.

In addition, they brought us some interesting places after work and even on weekends. For example, I experienced a tour to Ipoh, a night market, a night tour to Putrajaya, Batu Cave, a Malay wedding ceremony of JLPW staff, drinking in Chinatown, and so on. Sometimes I felt anxiety in local restaurants and shops because the staff spoke Malay and the menu was written in Malay and Chinese, the ordering



system was unique, and there were a lot of unknown foods. However, thanks to the lawyers' help, I fully enjoyed them. I had plenty of time to communicate with them and had a very good time exchanging our cultures.

I was also supported by Kobe University alumni living in Kuala Lumpur. We had dinner together

and exchanged our opinions about Malaysian culture from the perspective of the Japanese. They have lived in Kuala Lumpur for a long time, so I could get some advice, including information about delicious restaurants. This opportunity to talk directly with alumni who are succeeding overseas helped me to set goals for my future work and broaden my horizons.



#### 3. For My Future

I would say this internship will be my treasure in life and help me in the future in four aspects.

First, I could understand more about the common law system. As I mentioned, it was a nice opportunity to understand the common law system in Malaysia. I have studied common law, which was mainly about English law, so I could compare English law and Malaysian law, and I noticed a strong connection between English law and commonwealth laws. In the future, I will be involved in common law systems in business because English law and New York law dominate international commercial contracts, so a better understanding of common law will help me in my work.

Second, it was a great opportunity to make friends in Malaysia, as there are many excellent lawyers in JLPW who are almost the same age as me. Even after the internship, I continue communicating with them via SNS and enjoying the cultural exchange. Since they are lawyers, we can exchange legal opinions.

Third, through practical experience in JLPW, I found an area of particular interest in dispute resolution. I am thinking of deepening the curious points I found in the internship in my master's thesis. Furthermore, I felt the gap between studying theory and practical work, so I noticed that considering practice in writing my master's thesis is important. I believe that this internship will make my studies more fulfilling.

Finally, I became confident communicating with foreigners in English and living in foreign countries. It was the first time I had lived in a so-called developing country for more than one month, so before starting the internship, I was worried about life in Malaysia and my health. Although I was sometimes confused by the difference in hygiene levels from Japan, I spent about a month in Malaysia without any major problems. Also, when I had problems with my housing, I could communicate with the local people and solve them smoothly. Thus, this experience and confidence will support me if I have the opportunity to work overseas in the future.



### 4. Conclusion

In conclusion, I am extremely happy to have had this internship opportunity at JLPW. However, I could not complete it without the support of lawyers and staff of JLPW, Kobe University, and my family. I sincerely thank everyone who supported my internship. I will definitely use this experience in my future studies and work.
