My first task was to help with due diligence. By investigating target individuals and companies for adverse information or records, I helped clients assess and anticipate business risks in the course of future transactions. In the process, I learned to evaluate business risks from different aspects. At first, I didn't know where to look into individuals and companies. The team members of the law firm explained to me the purpose and manner of due diligence. Later, I successfully completed the

investigation. When I had some questions, the team members answered me in detail.

My second task was to complete a due diligence report survey. By organizing documents such as board resolutions and minutes of meetings of the client's future cooperative companies, I could help the client control the business risks and reduce the risks of future cooperation. Actually, due to the very high volume of due diligence, it was very challenging for me. Not only did I have to navigate through a lot of documents to analyze the risk points, but I also had to put together a lot of materials. As a result, I spent a long time every day, which lasted about a week and finally submitted my report document to my leader before the deadline.

During my internship in Malaysia, I deeply felt the inclusive and diverse culture of Malaysia. In fact, Malaysia follows a mixed legal system, primarily influenced by English common law, Islamic law (Sharia), and customary law. The British colonial legacy has significantly shaped Malaysia's legal system. Apart from my internship in Kuala Lumpur, I also visited Malacca on my own. I visited many famous places in Malacca and tasted the local specialties. I was also invited to have lunch together with the locals, who were very warm and friendly, and I felt the kindness and warmth of Malaysian people. And since March is the local Muslim festival, I was lucky to experience the local specialties of food culture.

In conclusion, during this experience, I not only learned the knowledge of legal practice but also felt the charm of teamwork. One of the things that impressed me deeply was that my colleagues in the law firm were very friendly and had the spirit of helping each other, which also deeply affected me. These experiences will help me better make a career path and plan for myself before securing a job. Meanwhile, when I came to Malaysia, I really enjoyed the food. I didn't have much chance to visit many places this time, but next time I will go again with my friends and family to different cities in Malaysia to experience the charm of different cities.
