Lesson topic

This course covers the latest trends in international trade policies and regulations from three perspectives, namely human rights, environment protection, and economic security. This course also will touch upon recent developments coming from the increasing importance of digital markets. In addition, this course will explain recent trends in major countries such as Japan, the United States, and European nations.

These trends have been influenced by various factors including geopolitical interests, diplomatic initiatives, industrial policy or civil interest, but they all share the common feature of using corporate and economic activities as “leverage” to achieve objectives in relation to certain initiatives and civil interests. As such, these trends and related regulations have a large impact on corporate activities that, in turn, influence trade. For example, recent trends in supply chain risk management necessitate companies have an accurate understanding, and means of articulating the intricacies, of their global supply chains, allowing them to appropriately adjust to shifts in such trends with timely, company-wide management decisions. Further, it is expected that trade rules on human rights, environment protection, and economic security will be developed by countries either multilaterally, through a plurality (among countries sharing common values) or unilaterally, and with the involvement of non-governmental actors.

Accordingly, companies are in need to keep track of these new trends in trade, not only separately (i.e., understanding specific trends), but also comprehensively (i.e., understanding how the trends relate to one another and generally impact regulation). As these trends represent important management issues, companies should react strategically by not only complying with applicable rules based on accurate information collection and analysis, but also by participating in the formulation of such rules when possible and appropriate.

Lesson target

Upon completion of this course, students should be able to follow and understand the current trends in trade policies and regulations involving human rights, the environment, and economic security in a systematic manner, and to interpret the economic impact of these trends.

Syllabus and plan

In this course, lectures in each session will be given by attorneys of Nishimura & Asahi belonging to the international trade practice area, including:

- an attorney who engaged in trade negotiations and disputes while working in government agencies such as the Ministry of Economy, Trade and Industry, the Ministry of Foreign Affairs, and the Ministry of Finance;
- an attorney who engaged in establishment of legislation on economic security, while working in government agencies such as the Ministry of Finance;
- an attorney who has long been involved in issues of human rights and business in an international organization and industrial association; and
- an attorney who has practical experience working with cutting-edge trade policies and regulations in overseas law firms and think tanks.
