Lesson topic

This program is designed to help students better understand the diversity of legal systems and social cultures in Asia. Its goal is to build inclusive and mutually beneficial relationships among lawyers in the next generation. Through lectures and workshops given by excellent academics and practitioners from various places and backgrounds, students will learn the value of sustainable diversity in legal cultures and how productive relationships can be constructed under these circumstances.

Lesson target

Upon completing the course, students should be able to understand the differences (1) in legal cultures among jurisdictions in Asia and beyond and (2) in the measures of dispute management mechanisms for cross-border disputes, including alternative dispute resolutions (ADRs) in various jurisdictions in the context of comparative law and culture.

Syllabus and plan

We will discuss extensively the current issues arising in cross-border disputes in Asia and elsewhere and the recent development of dispute management.

The course is organised with the support of organising members from various backgrounds in research and practice. The guest speakers are carefully selected by these members based on their expertise, special experience, and knowledge relevant to the specific topics to be discussed. Substantial time for discussion between the speakers and students will be reserved after each lecture.

The classes are scheduled between the middle of August and early September.

Evaluation method

- Engagement in the class discussion (50%)
- Final essay (50%)

Evaluation baseline

- Engagement in the class discussion (50%): Degree of internalising knowledge and critical thinking. Students are expected to participate in discussions actively.
- Final essay (50%): The final essay should include appropriate research questions, logical arguments, and evidence based on the course discussion. It must also include references.
