Lesson topic

International dispute settlement and the procedure of the International Court of Justice. Students are required to read and discuss, with the instructor, the original version (in English) of the ICJ Decisions (Judgments, Orders and Advisory Opinions).

Lesson target

Students are expected to obtain the ability to read the authentic international decisions and to discuss them with foreign academics and practitioners.

Syllabus and plan

Depending on the volume of the decisions, 3 or 4 classes will be devoted to the analysis of one decision, as follows:

Students must read all of the above decisions and, if possible, make presentation on them.

Evaluation method

Evaluation will be based on the reading of decisions (making summary of them), the presentation by each student and the discussion of participants.

Evaluation baseline

Criteria: a) understanding of the background of the case (fact, argument, applicable law), b) correct understanding of the ICJ's finding and reasoning, c) putting the case in the context of the ICJ case law, and d) discussion with others to deepen the understanding.

Notice (include info. on related class)

It is desirable that students already studied international law in the lectures 'International Law 1 and 2' and/or 'Law of International Organisation'. The English conversation skill is much more needed than the knowledge of international law.

Review and preparation

Students are recommended to study, by themselves, the basic structure of the peaceful settlement of dispute, especially the structure of the ICJ procedure.
