#### Lesson topic

The World Trade Organization (WTO) is an international organization which represents the world trading system. It governs trade agreements covering trade in goods, trade in services and trade-related aspects of intellectual properties. This course tackle WTO Law by introducing legal texts and reports which the WTO Dispute Settlement Mechanism has delivered so far. It also discusses root causes of, and necessary reforms for, the current WTO crisis both in trade negotiations and dispute settlement.

#### Lesson target

By taking this course, participants will understand: 1) the development history of the world trading system from the GATT to the WTO; 2) fundamental disciplines which support the trading system; and 3) the function of the dispute settlement mechanism. Participants will also understand root causes of, and necessary reforms for, the current WTO crisis both in trade negotiations and dispute settlement.

#### Syllabus and plan

The plan of the course is as follows:

- 1) History of world trading system; WTO as an international organization; Round negotiations; WTO Agreements
- 2) Dispute settlement including the Appellate Body vacancies
- 3) Prohibition of Quantitative Restrictions & Tariff Bindings
- 4) Non-discrimination 1: Most-Favored Nation
- 5) Non-discrimination 2: National Treatment
- 6) General Exceptions
- 7) Security Exception
- 8) Trade Remedies; New Issues

#### Evaluation method

The grading will be based on course participation (30%) and a short term paper (approximately 2500 words including footnotes) (70%).

#### Evaluation baseline

Grades will be determined in accordance with the degrees of each participants' achievement of the course objectives above.

#### Notice (include info. on related class)

Though it is much easier to understand if you have already studied courses such as Public International Law and International Investment Law, it is not the prerequisite for taking this course.

#### Review and preparation

Students are encouraged to prepare for each of the class, read the reference materials and actively engage in discussion in class. Extra reading is encouraged, but not compulsory.
