#### Lesson topic

In an era marked by immense global challenges, the concept of sustainable development has been frequently cited as a vision for transforming our world. It has been over 30 years since the term was coined at the international forum. However, despite intensive discussions, both theoretical and practical ambiguities surrounding sustainable development persist. Despite remaining skepticism, the concept has continued to guide international law in evolving into an effective problem-solving tool.

This course will explore the role of international law in promoting sustainable development. In this course, students will examine the meaning of the concept of sustainable development, study its functions in law-making and law-applying processes, and analyze how international legal instruments intersect with and contribute to the achievement of the Sustainable Development Goals (SDGs), while clarifying the limitations and challenges that underpin the interrelationship between international law and sustainable development.

#### Lesson target

This course will be structured around the following specific learning outcomes:

- i) Students can identify the value clashes and global issues using the concept of sustainable development;
- ii) Students can explain the legal significance and limitations of the concept of sustainable development;
- iii) Students can retrieve legal documents and analyze their contents;
- iv) Students can explain how international law and its institutions promote sustainable development.

#### Syllabus and plan

This course will be conducted in a seminar style. Based on the textbook, students will share their opinions and analyses. The instructor will explain the concepts while also raising questions for discussions. Students will also be expected to make presentations.

#### Evaluation method

#### Evaluation baseline

- Engagement in the class discussion & Group work: The degree of internalizing knowledge and critical thinking will be assessed. Students need not be afraid to lose points for providing wrong answers. Students should contribute and collaborate in the group project.
- Reaction papers: Whether students have sufficiently engaged with the reading materials prior to each class and to enhance active in-depth discussions.
- Poster presentation & Term report: The level of achievement of the learning objectives of this course.

Students are expected to be familiar with the basic concepts of international law, such as state sovereignty. This course is open to students not enrolled in KIMAP (Kobe LL.M.), including exchange students and special auditing students.

Please bring your PC, which will be needed to read other students' reaction papers and to conduct internet-based research on legal materials.

This course will require group work.

#### Review and preparation

Students are expected to read the assigned reading materials prior to attending each class and be prepared for discussions. Reaction papers must be submitted 24 hours before the class. After each class, review the discussions of each class and practice legal research skills.

Kobe University requires 45 hours of study from students to award one credit, including both in-class instructions as well as study outside classes. Students are required to prepare for each class and complete the review after each class, depending on the respective class goals.
